# Terms and Conditions V1 – effective date – 03/05/2024

## 1. Introduction

These Terms and Conditions ("Terms") govern your use of the services provided by Bid Bot Ltd, located at Waulk Mill, 51 Bengal St, Ancoats, Manchester M4 6LN, including the website and any associated features (collectively, the "Service").
